- 1. - 2. Evacuation plan showing exist routes and recommended action plan be displayed at conspicuous locations and shall be exhibited at all times, all escape / exit routes shall not be locked or encroached.
- 3. Fresh NOC would be required for any change in occupancy or addition / alterations in the building structure as per NBC and building bye/laws.
- 4. The Management has to maintain Fire Safety Measures at all times in good working condition as seen during the inspection.
- 5. Any Loss of life or property due to Non- functioning of Fire Safety Measures and other installations shall be the responsibility of the management/ owner.
- 6. All the Occupants must know the correct method of operation of the Fire Fighting System installed.
- 7. Additional / Alteration, if any, in the building may be verified by building authority.
- 8. The Fire Drills shall be conducted once in every three months for initial two years, thereafter once in every 6 months.

The NOC for occupancy is valid for the period of 2(Two) year from the date of issue, it is responsibility of the owner/occupier to apply renewal of fire NOC one month before expiry of above NOC.
